## ABOUT 2016

**Participation, innovation and organizational development** have been the main points of focus for the activities developed in 2016. We provided assistance for 330 beneficiaries: children with parents in prison, remigrant children, children from public residential care, children separated or at risk of becoming separated from their parents. For the first time in Romania a program for anger management has been created, titled: "Anger is Just an Emotion! Express it in a Healthy Way". One hundred and sixty educators from residential care centers of the laşi County Social Assistance and Child Protection Department have been trained to apply the program with children and youth displaying behaviour problems. For the constant support provided to prison inmates for the consolidation of family relations, Alternative Sociale was awarded the Silver Medal "PRO PATRIA ET ORDINE JURIS" and Honorary Diploma by the National Administration of Penitentiaries and the Ministry of Justice.

## ORGANIZATIONAL DEVELOPMENT THROUGH DONATIONS FOR ALTERNATIVE SOCIALE CAUSES

Innovation, cooperation and development in the social field – three key concepts that define Alternative Sociale's activity related to supporting the community and to contributing to the wellbeing of the persons from vulnerable categories.

In **2016** the funds donated by private and legal persons have been used for providing assistance to the following categories of beneficiaries: children which are "invisible" to the community (such as the children with one or both parents in prison) and children which are "home alone" — children affected by the labour migration of their parents.

In this context, **30** representatives of the business sector from the Moldova region attended the conference "Challenges of the business sector: online marketing, non-returnable funds and economic growth, involvement in supporting the community". This activity contributes to reaching our organizational development objective through the diversification of fundraising methods for the implementation of Alternative Sociale's programs.

The goal of the project "Strengthening the Role of NGOs in Developing Social Services" was to facilitate the access of children (and of their families) from the Moldova region, to social services for the prevention and reduction of the negative effects of labour migration.

In 2016 ...

children from 18 cities and communes from the laşi counties benefitted from support services (and material aid), for the prevention and reduction of the negative effects of migration (risk of abuse/neglect, social, school, cultural adjustment, behaviour issues.

**65 000** 

persons had access to the advice of Alternative Sociale professionals through the association's Facebook page. The activity was part of the campaign "Are you going to work abroad? The social worker will help you: your child will be protected!".

persons received the "Guide on accessing social services for families in labour migration".

posters were distributed to public providers of social services from laşi county.

social workers from laşi county have been informed on the specifics of the psycho-social assistance of families affected by labour migration and sensitized on the importance of non-discrimination in providing social services and conducting community education campaigns.

public and private institutions from laşi county assigned representatives to attend a workshop for the promotion of co-decision, co-provision and co-funding social services.





# CHILDREN SEPARATED OR AT RISK OF BEING SEPARATED FROM THEIR PARENTS

**TOGETHER FOR CHILDREN** 

**"Children separated or at risk of being separated from their parents"** refers to the situation of children whose parents work abroad, remigrant children (children who returned to Romania after having moved to another country with their parents in order to be raised, educated, cared for), children of divorce or with one or both parents in prison.

- 100 children separated or at risk of becoming separated from their parents participated in activities designed to develop their independent life, socialization or career skills.
  - activities have been conducted by the association's volunteers in order to prevent problems such as: school, social, cultural adjustment issues, behaviour issues, labelling and in order to facilitate the reintegration of children separated or at risk of becoming separated from their parents.
  - professionals (representatives of media and of institutions involved in the project) attended the press conference organized with the purpose of informing the local community with regards to the services provided in the purpose.
- children separated or at risk of becoming separated from parents which present social issues of a more serious nature (risk of abuse/neglect, risk of school abandonment, social, cultural, school adjustment issues, behaviour issues) benefitted from specialized social services for the prevention or reduction of the consequences of separation or for the prevention of separation.
- children separated or at risk of becoming separated from parents received social support and material aid for recovering from crisis and vulnerability situations.



We need such projects – the laşi City Hall supports such projects, as you saw during 2016 and I am convinced that for the next year the amount that the City will contribute with for projects in the social field, particularly for children, will be greater.

## YOUTH SEPARATED FROM ONE OR BOTH PARENTS

**PARTNERSHIP FOR INCLUSION!** 



The project is an integrated approach for the improvement of the life quality and of the access to social services for youth at risk of social inclusion, including roma, from the counties of laṣi, Vaslui, Constanṭa and Mureṣ.

The project activities have been implemented by specialists from a consortium of 9 institutions (7 local and national NGOs and the laşi and Vaslui county social assistance and child protection departments), coordinated by "Alături de Voi" Foundation and including Alternative Sociale as a partner. The results produced by Alternative Sociale are:

- young persons, aged 16-29, separated from one or both parents and 10 parents/caregivers benefited from psychological counseling and social services for the prevention/reduction of the negative effects of separation.
- information activities on the topic of organized in the communes of Cotnari, Paşcani, Hârlău, Răducăneni etc.(laşi county) and Huşi, Pădureni, Murgeni, Zorleni (Vaslui county) with the participation of youth, for the prevention of violence and bullying, the reduction of the negative effects of migration and the prevention of trafficking in persons.
- young persons from Vaslui county have been trained as peer-educators on the topics of "Trafficking in human beings" and "Domestic violence", during the intercultural summer school "Education for your future", with the purpose of creating educational support opportunities for young pesons from the communities the trainees came from.
- 1 presentation clip for the services provided by Alternative Sociale was created ("Alternative Sociale Parteneriat pentru Incluziune" available on Youtube).

## THE FAMILY OF PRISONERS. COLLABORATION **PREVENTS** DISCRIMINATION

CHILDREN WITH PARENTS IN PRISON: INVISIBLE CHILDREN

The project aimed at developing support services for children whose parents are in penitentiaries in the counties of laşi and Vaslui. Also, information and awareness raising activities have been developed with regards to the difficulties these children face.

## **I** COLLABORATION PREVENTS DISCRIMINATION

Supporting the community reintegration of former inmates from the county of laşi, the improvement of the antidiscrimination measures, preventing social exclusion through the development of an inter-institutional collaboration mechanism — these are the main objectives of the project "Collaboration prevents discrimination" coordinated by the laşi Penitentiary in partnership with Alternative Sociale.



Results (for the year 2016) of the project "Collaboration prevents discrimination", financed by SEE 2009-2014 Grants through the RO10-CORAI Programme, managed by the Romanian Social Development Fund.

- representatives of local authorities and of the private sector attended 17 seminars organized in rural communities from laşi county (Popricani, Ciurea, Holboca, Bălţaţi, Dobrovăţ etc.) in order to identify solutions to problems that former inmates are confronted with in their attempt to reintegrate.
- copies of the "Guide for inter-institutional collaboration for the community reintegration of former inmates" have been distributed to professionals employed by Village Halls from laşi county.
- inmates received the brochure "The road to reintegration" with the purpose of facilitating their community reintegration.
  - representations of forum theatre have been performed in 7 communities from laşi county (Lungani, Târgu-Frumos, Dolheşti, Podu-lloaiei, laşi, Grajduri, Răducăneni); 194 persons attended the performances.
  - former inmates received cameras and attended a PhotoVoice program.
  - photos and captions have been presented in a Photo Voice exhibit with the purpose of informing and sensitising the local community with regards to the situation of former inmates.
  - institutions from Iași and Bucharest hosted the PhotoVoice exhibits: the Ministry of Justice, the Iași Palace of Justice, the Iași International Airport, the schools from Târgu Frumos, Lungani and Dolhești (open air exhibit) and the Iași Union Museum (open air exhibit).
  - former inmates received assistance for their community reintegration.
  - journalists from laşi attended the workshop "What can journalists do for the community reintegration of former inmates?". The scope of this event was to consult the representatives of the media on the optimization of practices and sensitization of the public.





RESIDENTIAL CARE: FROM RISK TO PROSOCIAL OPPORTUNITIES

The specialization of the personnel from residential care centres in working with children with (pre-)delinquent behaviour and the development of anger management abilities and of prosocial behaviour for children from the centres belonging to the laşi County Social Assistance and Child Protection Department are the main objectives of the project.

- students from the Social Work specialization of the "Alexandru loan Cuza" University of laşi attended an information meeting on the topic of the social assistance of children from residential care centres of the laşi County Social Assistance and Child Protection Department. The students learned about the specifics of the social worker's activity in placement centers and received contact information in order to facilitate their involvement in volunteering activities.
- Anger Management manual "Anger is an Emotion! Express it in a Healthy Way" was created by the Alternative Sociale experts.
- copies of the program have been distributed to the personnel of the residential care centres of the Iaşi County Social Assistance and Child Protection Department.
- educators, social workers and psychologists from residential care centres of the laşi County Social Assistance and Child Protection Department have been trained on implementing the Anger Management program developed by Alternative Sociale.
  - children from residential care centres, aged 10 to 18, attended the activities of the program "Anger is an Emotion! Express it in a Healthy Way".

2016 6 years from the first issue of the Social Economy Journal

In 2016 two issues of the Social Economy Journal (Nr.1/2016, Nr.2/2016) have been published; in total they contain 18 scientific articles. The content can be accessed free of charge at http://profitpentruoameni.ro/revista-de-economie-sociala/.

The publication provides a framework for promotion, reflection and debate for topics relevant to the field of social economy. Innovative approaches for the development of social economy are encouraged, bringing together theoretical perspectives from academia and research with practical experiences of profit and non-profit organizations, of the experts from social enterprises and administration.

The social economy Journal is published in Romanian and in English and is edited in partnership by Alternative Sociale Association and the Faculty of Phylosophy and Social-Political Sciences from the "Alexandru loan Cuza" University of lasi.



VOLUNTEERING

- volunteers of Alternative Sociale completed 2365 of work comprising specific activities from the field of social work, forum theatre or information campaigns.
- volunteers have been trained in order to provide support services to children at risk of becoming separated from one or both parents, in two youth centres established in two partners secondary schools "lon Simionescu" lasi si "Alecu Russo" lasi.
- volunteers have been involved in the production of the forum theatre on the topic of the community reintegration of former inmates: "About the detention and the community of lonut".
- volunteers participated in the activities dedicated to the Diaspora Week (14-21 august) organized by the laşi City Hall. They implemented a street information campaign with regards to the rights of the citizens working abroad in other EU countries (social benefits related to legal employment), discussed the effects of separation (from the parents working abroad) on the children left behind and provided advice on how parents can help their children overcome the difficult period generated by their absence.
- Every week the Alternative Social experts provide information and counselling with regards to social benefits that children whose parents are working abroad are entitled to as a result of their legal employment.




